He began by discussing the pot of the banjo and the various issues. Different woods, even woods of the same species from different areas produce unique results due to varying densities. He makes pots of two types. The first is segmented. The second laminated. The future owner makes the choice.



For years, Lukas reported, he formed the banjo neck by hand and using antiquated radial arm saws. A CNC router machined now does the work



in less time and with greater precision. His wife Eden handles the beautiful inlay work on the fretboard and pegboard. Since acquiring the CNC router, his company even makes the bridges which they once purchased.

Does a preacher have a vice? Carl McCormack has one, a wooden bench vice which he shared with the membership. He made it of cherry and finished it with Danish oil.

ry. He also brought a beads and courage box he turned from walnut with a water based polyurethane finish.

Rachelle Logan presented a scroll saw box of walnut and maple with a wax finish, pointing out the number

of holes she had to drill. She also brought a figure of her cat carved from bass wood with acrylic finish.



#### March 5, 2024 — Planning a Project
