Pat Morris and Phil Brown discussed the uses of hide glue. Pat demonstrated dried hide glue which requires mixing with water and heating to 140F. He demonstrated the ability of hide glue to provide a good bond by simply rubbing the two pieces together until they stick and then allowing the glue to cure. Pat also showed how to use a veneer hammer to applying veneer with hot hide glue.
